

Articulation Agreement between
JAMESTOWN COMMUNITY COLLEGE
 and
SUNY COLLEGE OF TECHNOLOGY AT ALFRED
Health Information Technology

Based on our mutual concern for providing students with the opportunity to receive a quality education in their chosen field that might otherwise be unavailable to them, Jamestown Community College and SUNY College of Technology at Alfred subscribe to the following memorandum of understanding.

Following detailed discussion and exchange of information between personnel representing each institution, it was concluded that there is sufficient similarity between courses required in the *Health Information Technology* curriculum at the College of Technology at Alfred and the courses offered at Jamestown Community College that a one-plus-one agreement can be established. Students may complete one year of study at Jamestown Community College and subsequently transfer full credit to SUNY College of Technology at Alfred, said credit being fully applicable to the *Health Information Technology* program subject to the guidelines listed below.

- Time to Complete Degree:

The curriculum offered at SUNY/Alfred normally requires four semesters of study plus one summer session. Acceptance of 31-34 credits from the courses listed above requires 33-36 credits to be completed at SUNY/Alfred. These remaining credits and the course offerings at SUNY/Alfred permit a transferring student to fulfill the curriculum requirements with two additional semesters (27-30 credits) plus one summer session (6 credits) at SUNY/Alfred if courses are completed satisfactorily. However, due to the large number of credits to be completed at SUNY/Alfred, students transferring with a Quality Point Index of less than 3.00 may require three semesters and one summer at SUNY/Alfred.

- Quality Point Index:

With a Quality Point Index (Cumulative Index) of at least 2.0 and passing grades in transferable courses which total at least 31 credits at Jamestown Community College, the student is guaranteed acceptance into the *Health Information Technology* program at the SUNY College of Technology at Alfred.

- Practical Experience:

Students who transfer from Jamestown Community College will receive 300 hours of practical experience in a hospital/healthcare setting while a student at SUNY/Alfred.

- Time Frame and Provision for Program Review:

All students currently enrolled at Alfred State College and those admitted to begin their studies at Alfred State College in Fall 2006 through Spring 2008 who have not attended another college or university are eligible to be considered for this cooperative degree program. During this initial period, both institutions will monitor the effectiveness of the program with the intent of renegotiating this agreement and implementing any changes prior to the selection of students who will enter Alfred State College to begin their studies in Fall 2008.
