# MEMORANDUM OF AGREEMENT BETWEEN GRAND CANYON UNIVERSITY AND COCHISE COUNTY COMMUNITY COLLEGE DISTRICT

This Agreement is entered into on March 1, 2010 by and between Grand Canyon University (GCU), with its principal place of business located at 3300 West Camelback Road, Phoenix, Arizona 85017, and Cochise County Community College District (Cochise).

WHEREAS, the intrinsic benefits of the performance provided by GCU determined by the Parties to constitute full and adequate value for the use of Cochise facilities;

NOW, THERFORE, in consideration of the mutual promises and covenants herein expressed, the parties do hereby agree as follows:

#### **TERMS**

**Purpose of Agreement.** GCU will offer the following programs at Cochise: The RN to BSN track (as outlined in Exhibit A), the MSNL and the MS-L track and any other GCU College of Nursing and Health Sciences program that the parties mutually agree upon ("Program").

Performance by Cochise. To the extent possible without affecting Cochise operations, Cochise will provide classroom and support at no charge to GCU. Support includes classroom setup with a TV/VCR/DVD, laptop computer with PowerPoint and Internet capabilities, overhead projector and screen, a whiteboard/chalkboard with markers, and the capability to make copies, if needed. Restrooms will also be available during class time. Cochise shall work together with GCU to create and make available to Cochise marketing materials that describe and provide prospective students with all relevant information regarding the Programs.

**Performance by GCU.** GCU will provide the content, instruction, and academic oversight of the above mentioned Programs. GCU will provide the services enumerated in "Exhibit B" to this Agreement. GCU will maintain all required accreditations for the Nursing and Health Sciences Programs listed.

GCU shall provide a 20% tuition scholarship to on-site (ground) students approved by Cochise to participate in the program.

GCU shall also include the Programs in its general marketing efforts and, at the request of Cochise, shall conduct periodic marketing efforts specifically targeted at potential students for the Programs. GCU shall also conduct all necessary public relations activities designed to enhance and further the status and reputation of the Programs.

Terms of Agreement. This Agreement shall be effective as of March 1, 2010, unless earlier terminated in accordance herewith, and shall continue through February 29, 2012. Thereafter, this Agreement may be renewed for additional one-year terms by mutual written agreement. Either party may terminate this Agreement with 60 (sixty) days written notice. Any student enrolled in a Program at the effective date of termination will be assisted by the parties in completing the Program in which such student is enrolled at the time of termination.

Payment and Refund Schedule. On-site (ground) students approved by the Cochise to participate in the Program shall pay GCU the published catalog cost per credit hour less a 20% tuition scholarship provided by GCU, and online students shall pay GCU the published catalog cost per credit hour. Should a student change enrollment from on-site to online, the 20% tuition scholarship shall be forfeited. The terms of this section and its exhibits shall survive the termination of this Agreement and remain in effect until all Cochise students have finished their Program or terminated their enrollment at GCU.

Continuous Enrollment. An on-site (ground) student enrolled in a Program will receive the 20% tuition scholarship off the current catalog rate for all ground Courses in a Program as long as such student remains continuously enrolled in the on-site Program and takes the required Courses necessary to complete the Program. Continuously enrolled is defined as student being enrolled in each consecutive enrollment period based upon schedule. The only exception is an approved leave of absence which shall not exceed sixteen weeks or one term.

Passing Grade in Programs/Tracks. In addition, student must successfully pass courses with a grade of "C" or better for the RN to BSN program and a "B" or better for the MSN program.

Texts, Materials and Fees: It is the responsibility of students to purchase, at their expense, all required texts and materials and to pay all applicable GCU fees listed in the GCU student catalog. Coursework texts and materials can be ordered on-line.

**Assignment.** Neither party may assign this Agreement or any of the rights and obligations under this Agreement without the prior written consent of the other party.

Severability. Should any Section or any part of a Section within this Agreement be rendered void, invalid, or unenforceable by any court of law for any reason, such invalidity or unenforceability shall not void or render invalid or unenforceable any other Section or part of a Section in this Agreement.

Governing Law. This Agreement is made and entered into in the State of Arizona and the laws of said state shall govern its interpretation.

Entire Agreement. This Agreement and the attached Exhibits contain the entire understanding of the parties and there are not further or other agreements or understandings, written or oral, in effect between the parties relating to the subject matter hereof unless expressly referenced herein. Neither this Agreement nor any term hereof may be changed, waived, discharged, or terminated orally.

Authorization of Agreement. Each party represents and warrants to the other that the execution of this Agreement has been duly authorized, and that this Agreement constitutes a valid and enforceable obligation of such party according to its terms.

Attorneys Fees. If either party fails to comply with any of the provisions of the Agreement and the other party(s) take action to enforce such provisions or to enforce any payment stipulated to in the Agreement, the losing participant will pay the prevailing party reasonable costs and expenses, including attorneys' fees.

Conflict of Interest. This Contract is subject to cancellation pursuant to the provisions of A.R.S. § 38-511 regarding Conflict of Interest.

Sudan and Iran Scrutinized Business Operations. Pursuant to A.R.S. §§ 35-391.06(A) and 35-393.06(B), Contractor certifies that it does not have a "scrutinized" business operation in either Sudan or Iran, as that term is defined in A.R.S. §§ 35-391(15) and 35-393(12), respectively.

Indemnification. Each party (as "indemnitor") agrees to indemnify, defend, and hold harmless the other party (as "indemnitee") from and against any and all claims, losses, liability, costs, or expenses (including reasonable court-awarded attorney's fees) (hereinafter collectively referred to as "claims") arising out of bodily injury of any person (including death) or property damage, but only to the extent that such claims which result in vicarious/derivative liability to the indemnitee, are caused by the act, omission, negligence, misconduct, or other fault of the indemnitor, its officers, officials, agents, employees, or volunteers.

Insurance. Each party shall maintain workers' compensation as required by state law covering all of its employees employed in connection with the Program. In order to adequately insure their respective personnel for liability arising out of the activities to be performed under this Agreement, GCU and Cochise each agree to obtain and maintain in force and effect commercial general liability insurance in an amount not less than \$1,000,000 per occurrence covering Bodily Injury and Property Damage with an aggregate limit of at least \$2,000,000 as well as commercial motor vehicle liability insurance with a limit of \$1,000,000 combined single limit for bodily injury and property damage to insure themselves and their respective personnel for liability arising out of activities performed under, or in any manner related to this Agreement. GCU shall provide Cochise County Community College District with a certificate of insurance reflecting the coverage and limits as stated herein and shall name Cochise County Community College District as an additional insured, as respects the Commercial General Liability Coverage.

### Program of Study:

## Registered Nurse to Bachelor of Science in Nursing (RN to BSN)

#### Program Description

The RN to BSN program is designed for registered nurses with an associate's degree or diploma in nursing. The format and courses of the regionally accredited program are tailored to meet the needs of the adult learner RN, and to maximize strengths that the working RN possesses. A bridge course facilitates the transition of the working RN into the baccalaureate program. Courses are taught by experts in their respective fields who share knowledge and experience in areas of clinical patient care, healthcare management, and professional nursing practice and leadership. Opportunities are provided to apply concepts, theories, and research in the RN's clinical practice. Both the science and art of nursing are integral components of the program and are woven throughout. Graduates of the program are prepared to become leaders in the nursing profession.

#### Additional Admission Requirements

In addition to the general Undergraduate Admission Requirements listed in the Academic Catalog, the following admission requirements must be met.

- 1. Degree-bearing Candidates:
  - a. Possess a GCU-approved Associates degree in mursing from an accredited, GCU-approved college, university, or program.
  - b. Submit official transcripts bearing evidence of a cumulative GPA of 2.8. No transferable credits may have a grade below a "C" (2.00).
  - c. Possess a current unencumbered, unrestricted license as a registered nurse in the state where they are employed as an RN.
- 2. Non-degree-bearing/Nursing Diploma Candidates:
  - a. Submit proof of successful completion of an approved nursing program.
  - b. Tender official transcripts bearing evidence of a cumulative GPA of 2.80. No transferable credits may have a grade below a "C" (2.00).
  - c. Possess a current unencumbered, unrestricted license as a registered nurse in the state where they are employed as an RN.
  - d. Be prepared to transfer or complete the following general education competencies that are not integrated into the program core with a minimum grade of "C" (2.00)
    - i. 6 credits of English Composition
    - ii. 5 credits of Scientific Inquiry
    - in. 3 credits of History
    - iv. 4 credits of Humanities
