

ARTICULATION AGREEMENT
HAMPSHIRE COLLEGE AND PALM BEACH COMMUNITY COLLEGE

Through this agreement, Hampshire College and Palm Beach Community College (PBCC) hereby enter into an educational agreement designed to provide the participating students the opportunity to complete a Bachelor of Arts degree. The purpose of this agreement is to enable PBCC honors program students who enter Hampshire with an associate in arts (A.A.) transfer degree to make a smooth transition into the Division II system. This agreement is intended for PBCC honors program graduates; non-honors graduates may be considered on an individual basis.

While Hampshire College does not specifically state minimum criteria, the admissions committee thoroughly reviews all applicants for their potential success in Hampshire's program. Applicants' files are assessed for academic breadth, rigor, and performance. Essays are evaluated for content and critical thought. Other factors considered include demonstrated community involvement, intellectual curiosity, independence, and self-direction.

PBCC students admitted to Hampshire College may expect the following:

1. Courses completed satisfactorily with a grade of C or better will be accepted toward a Hampshire degree. Courses completed through dual enrollment arrangements with high schools will be accepted if the student has earned an A.A. transfer degree from PBCC.
2. Students who satisfactorily complete the General Education requirements specified by PBCC will fulfill the Hampshire College Division I requirements in the schools of Humanities, Arts and Cultural Studies; Interdisciplinary Arts; Natural Science; and Social Science. Students will also be able to satisfy the Division I requirement in school of Cognitive Science by taking one of the courses included in the addendum included in the next page. Together with the five courses used to satisfy distribution requirements, three other courses from the PBCC transcript will be identified to complete the Hampshire Division I program.
3. Prior to a student's admission to Hampshire, transfer courses beyond those needed to fulfill first-year requirements will be reviewed by a faculty member in the student's proposed program of study to determine how many semesters of enrollment at Hampshire will be necessary. Students admitted to Hampshire who complete work in a discipline similar to that pursued at PBCC can normally expect to spend two additional years at Hampshire College; two semesters in Division II and two semesters in Division III. The academic progress of individual students is assessed by the Division II committee at the end of each semester to ensure adequate academic progress toward these expectations.

Hampshire and PBCC agree to publicize this agreement among students and faculty and review this statement once a year. Program changes by either Hampshire or PBCC can be incorporated into this agreement, as agreed by both parties.

This agreement will be in force for the 2008/2009 academic year and for each successive academic year, unless canceled by either institution. Hampshire or PBCC may terminate this agreement with a written notice of one year. If this agreement is canceled, it will not affect students enrolled in and accepted to Hampshire College at the time of termination.

Termination/Modification

This agreement is subject to change and/or modification by mutual written consent between the parties hereto. It is understood that this agreement may be modified by Hampshire College with the directives of the President or academic leadership at Hampshire College, the statutes governing Hampshire College, or the policies of the Board of Trustees of Hampshire College or by PBCC in accord with the directives of the PBCC Board of Trustees or Florida Division of Community Colleges. This agreement may be terminated by either party upon written notice to the other party, given at least one year in advance of such termination date.

Students who satisfactorily complete the General Education requirements for the A.A. transfer degree will normally fulfill the Hampshire College Division I distribution requirements in the Schools of Humanities, Arts and Cultural Studies; Interdisciplinary Arts, Natural Science and Social Science. Transfer students who do not meet the distribution requirement in any of Hampshire's five Schools will be expected to complete the requirement in their first semester of enrollment.
