Please reference our College Catalogue for additional information. A maximum of 70 semester hours may be transferred from two-year institutions. The School of Business requires that at least 50% of the business credit hours be earned at Western New England College. The Business Administration Transfer Option will serve as an excellent option for students interested in transferring into any of following majors offered at Western New England College: Accounting, Business Information Systems, Finance, General Business, Management, Marketing, Marketing Communication/Advertising, and Sport Management.

^{*} The following Holyoke Community College courses will count towards satisfying Western New England College's general College requirements: *Business* - CSI 242 Applied Database Management, any approved business course(students should confirm with the Admissions Office at Western New England College); *Social Science* - PSY 110 Intro. to Psychology <u>or</u> SO 110 Intro. to Sociology, any history course (one); *Mathematics* - MTH 142 Statistics, MTH 160 Intro. to Matrices & Linear Programming, MTH 162 Applied Calculus; *General* - COM 150 Public Speaking, any course listed above. Business courses from a college not accredited by AACSB that are determined to be equivalent to 300-400 level courses at Western NewEngland College will be considered for transfer credit (up to one course). With this in mind, the College will apply credit for one course that is required for the intended major. One additional course identified as equivalent to a 300-400 level course at Western New England College will be considered for transfer credit as a business elective if the course does not satisfy a specific requirement for the intended major.
