

CORE-TO-CORE TRANSFER AGREEMENT
between
CAMDEN COUNTY COLLEGE
and
TEMPLE UNIVERSITY
of the Commonwealth System of Higher Education

Camden County College (CCC) and Temple University (Temple) enter into this agreement in order to facilitate the transfer of students from CCC into Temple, and to support their academic success in baccalaureate degree programs.

This agreement applies to students who first enroll at Temple for or after the fall 1999 semester, having received an Associate degree in one of the following programs in or after 1980:

Associate in Arts:

Any Liberal Arts and Sciences option

Associate in Science:

- 1) Any Liberal Arts and Sciences option
- 2) Criminal Justice
- 3) Elementary/Secondary Education
- 4) Human Services
- 5) Engineering, if and only if the student is

certified to Temple's Director of Core and Transfer by the Community College's Transfer Office.

For those students, Temple agrees to accept the general education embedded in the CCC degree in lieu of all the requirements of its undergraduate University Core Curriculum except two Writing-Intensive courses to be taken at Temple.

Other CCC degrees that incorporate the same requirements as one of these degrees may be added to this agreement in the future, after the review and approval each institution considers appropriate, and by mutual consent.

Eligible CCC graduates enrolling at Temple will be identified upon admission to Temple, with the assistance of CCC. The fact that they have satisfied Temple's Core requirements by Core-to-Core transfer will be noted on all pertinent student records.

Core-to-Core Transfer satisfies all the requirements of the University Core Curriculum except for two Writing-Intensive courses to be taken at Temple (one of which normally will be an upper-level major capstone course). Core-to-Core Transfer does not alter the requirements of the student's major field of study or the requirements of the student's Temple school or college. While those sets of requirements may include courses that also meet Temple's Core requirements, they are not themselves Core requirements.

CCC graduates entering Temple under the terms of this agreement go through Temple's normal transfer admissions process and therefore must meet all applicable Temple requirements and deadlines pertaining to application for admission, orientation and registration, and payment of tuition and fees. They will abide by the policies and procedures, and any revisions thereof, that apply to all Temple students.

Both institutions agree to:

- 1) Consult with each other through appropriate channels prior to implementing major changes in policy or curricula that directly affect students transferring under the terms of this agreement, and keep each other informed of any other changes of policy or curricula that affect those students.
- 2) Collaborate in providing students with information and academic advising about this agreement, Temple's academic programs and requirements, and the process of transferring to Temple.
- 3) Exchange data and documents that will contribute to the maintenance and improvement of this Core-to-Core arrangement, enhance the transfer process, and promote effective cooperation between institutions. These will consist of data about individual transfer students, including admissions information and grades, and reports on the results of program reviews, assessments of student learning, and decisions of curricular and other committees. When required by law, the institution(s) will exchange data only after obtaining appropriate permission from the student.
- 4) Facilitate and support consultation and collaboration between their faculties related to this agreement, general education, degree requirements, and other academic matters.

REVISION, RENEWAL AND TERMINATION OF THIS AGREEMENT

The Temple University Provost's Office and CCC Transfer Office are responsible for identifying, and communicating to each other, changes in the policies or requirements of their respective institutions that affect this agreement.

This agreement will be in effect as of the date of its signing, for eligible students entering Temple for or after the fall 1999 semester. It will be reviewed annually by the appropriate parties at each institution, and will be renewed automatically until superseded by a new agreement or formally terminated. Either institution may terminate this agreement at any time by written notice at least one year in advance of the effective date of termination. Should this agreement be terminated, it is understood that the termination

will not apply to students already accepted to Temple University under the terms of this agreement, but not yet enrolled in classes at Temple.

CCC and Temple understand that they shall act in an independent capacity in the performance of this agreement, and shall not be considered as employees, agents, affiliates, or subsidiaries of each other. Neither Temple nor CCC have the right to bind or obligate one another in any manner inconsistent with or unrelated to this agreement. This agreement is governed by the laws of the Commonwealth of Pennsylvania.

The willingness of both institutions to enter this agreement in order to 1) facilitate the transfer of students from Camden County College into Temple University, and 2) expand those students' opportunities for academic success at Temple, is indicated by the following signatures.
