

**Agreement of Articulation
Between
Radford University – Information Systems Technology Programs
and
Central Virginia Community College**

PROGRAMS OF STUDY FOR COMPUTER SCIENCE AND TECHNOLOGY, AND INFORMATION SCIENCE AND SYSTEMS

(including concentrations in computer science, Software Engineering, Database, Networks,
Information Systems, Enterprise Systems Development, and Web Development)

WHEREAS, Central Virginia Community College and Radford University exist to provide educational services and opportunities: and

WHEREAS, Central Virginia Community College and Radford University cooperate effectively to ensure that citizens of the Commonwealth receive the highest quality educational experience and opportunities; and

WHEREAS, Central Virginia Community College and Radford University desire to reduce transfer barriers between the two institutions; now and

THEREFORE, Central Virginia Community College and Radford University make the following articulation agreement:

GENERAL PROVISIONS

1. Admission to the **Radford University (RU)** Bachelor of Science programs in Computer Science and Technology, and Information Science and Systems, will be open to any **Central Virginia Community College (CVCC)** student who has earned, from the date of this agreement forward, an Associate of Applied Science degree in Information Systems Technology (ITS).
2. Only courses completed at an accredited institution with a grade of “C” or higher will be considered for transfer into this program.
3. The program requirements may be modified to confirm to any changes in RU or degree requirements of the respective programs. Any such revisions will be communicated to currently enrolled students and the Vice President of Instruction and Student Services of CVCC by November 15th preceding the academic year in which the new requirement would take effect. RU reserves the rights to change, when warranted, any of the provisions of this agreement, course offerings, assigned teaching faculty, calendars, class locations, and fees, as might be required.

GENERAL EDUCATION REQUIREMENTS

For students articulating to RU under this agreement, the RU requirement that 45 credit hours must be taken at RU will be deemed fulfilled.

For students articulating to RU under this agreement, the RU requirement that 30 of the last 39 credit hours must be earned at RU will be deemed fulfilled.

REMAINING RU REQUIREMENTS

All remaining requirements for any of RU's Information Technology programs may be completed in two additional years of study. Student's transferring under this agreement will need to meet with an advisor in the College of Information Science and Technology at RU to plan their remaining program of study.
