ARTICULATION AGREEMENT

between

Montgomery County Community College Radiography Major

and

Pennsylvania College of Technology Applied Health Studies with Radiography Emphasis

I. PURPOSE

This agreement establishes a mechanism for graduates of Mongtomery County Community College 's Radiograpy major to transfer specific earned credits into the Baccalaureate degree in Applied Health Studies at Pennsylvania College of Technology.

II. GOALS

- A. To provide a well-defined mechanism for graduates of the Radiography major at Mongtomery County Community College to begin the B.S. in Applied Health Studies at the appropriate entry point.
- B. To recruit associate-degree graduates whose career goals include acquisition of a baccalaureate degree.

III. TRANSFER/ENROLLMENT REQUIREMENTS

Pennsylvania College of Technology will accept Montgomery County Community College graduates into the Applied Health Studies major if they meet the following requirements and adhere to the Admission Procedures (Part V).

- A. Montgomery County Community College applicants must have a final cumulative GPA of 2.0 or higher.
- B. Montgomery County Community College applicants must have completed the courses to be transferred (see Part IV) with grades of C of higher.
- C. Of the final 60 credits required by the bachelor-degree curriculum, at least 36 credits must be completed at Penn College.
- D. A total of 47 credits will be transferred from the Associate degree for satisfactory completion of the Radiography courses, graduation from an accredited program, and the national registry RT(R), current and in good standing. All coursework must be completed with a grade of "C"or higher to be considered for transfer.
- E. Bachelor of Science Applied Health Studies Require CORE and ELECTIVES (31-33 credits)

Except where "OR" is noted, all of the above courses are to be completed for this degree.

A total of 15 elective credits, selected from an approved list, must be completed. Of the 15 credits, a minimum of 10 credits must be at the 300-400 level.

Of the final 60 credits, at least 36 credits must be earned with Pennsylvania College of Technology courses.
